On November 18, 2022 the Division of Reclamation, Mining and Safety concluded its review of the Surety Reduction Request application submitted to the Division on October 28, 2022, addressing the following:

Zephyr Gold USA Ltd. is requesting a reduction in the financial warranty to the revised bond estimate included in the September 2022 DRMS inspection report for P-2013-002.

The decision reached by the Division is: Approve.

This is a reduction of (\$19,216.00). In accordance with Rule 5.3.5(2), the Division shall release this Financial Warranty amount within thirty (30) days from this notice. This decision reduces the amount of the financial warranty, and does not approve any release of reclamation responsibility for the tasks associated with this request.
