Dear Mr. Sprague:

The AM2 application was received July 22, 2021 and was deemed complete for the purposes of filing on October 11, 2021.

The AM2 application is under a Mined Land Reclamation Board (the "Board") order, dated July 19, 2021. All materials needed to be in approvable form within the statutory deadline of 365 days from when the application was filed (Rule 1.4.1(9)). The AM2 application was filed on October 11, 2021 and needed to be approved by October 10, 2022. As of this letter, the applicant has not demonstrated that the AM2 application meets the minimum requirements of the Act, Rules and Regulation (Rule 1.4.1(10)).

Therefore, this matter is scheduled for a Formal Public Hearing before the Board (Rule 1.4.1(9)). The hearing will be held at 9:00 a.m. on January 25, 2023 or as soon thereafter as the matter can be considered. This Board hearing will be held by a virtual Zoom hearing.
