Dear Mr. Takami,

The 2023 schedule of the Mined Land Reclamation Board (MLRB or Board) has changed. The meeting planned for January 25 and 26, 2023 has been rescheduled to occur on January 18 and 19, 2023. Grand Island Resources, LLC. (GIR), is scheduled for three hearing before the Board during the January 18 and 19, 2023 Board meeting. The first hearing will be for the consideration of GIR's appeal of the Colorado Division of Reclamation Mining and Safety's (DRMS or Division) determination that the Cross Gold Mine (M-1977-410) is a Designated Mining Operation as defined by Rule 1.1(20). The second hearing will be for the consideration of GIR's request to lift the Cease and Desist order put in place by the MLRB for violation no. MV-2021-017. The third hearing will be for GIR to provide a status update on the corrective actions required by the Board's February 18, 2022 order for MV-2021-017.

The hearings will be held beginning at 9:00 a.m. on January 18, 2023 or as soon thereafter as the matters can be considered. These Board hearings will be held virtually by Zoom.
