Dear Mr. Langenfeld,

On December 22, 2022, the Division of Reclamation, Mining and Safety received your 112 Construction Materials Reclamation Permit Amendment package for the Hayden Gravel Pit site, File No. M-1987-164. Preliminary review of the information received determined that the following items must be received before the Division can consider your application as being submitted and technical review can begin:

# **General Exhibit Requirements**

## 6.4.4 Exhibit E - Reclamation Plan

1. The site introduction and Exhibit E included with the Amendment Application states that post mining land use of the area will be "dry rangeland". Item No. 12 of the Application Form states that the post mining land use will be 'General Agriculture'. Please submit a revised page 4 of the Application Form which updates the post mining land use to either include or be replaced by the Rangeland category. Please note that contrary to the Application Form directions, more than one box can be checked.

# 6.4.7 Exhibit G - Water Information

2. Page G-2 of Exhibit G states that wetland delineations from 2013 will need to be reconfirmed/updated prior to disturbance. Please note that this confirmation will need to occur before the Division can issue a formal decision for Amendment 4. Any new findings from this additional evaluation will also need to be updated on all maps related to the application.



#### 6.4.19 Exhibit S - Permanent Man-made structures

3. The proof of delivery of structure agreements referenced in Exhibit S do not seem to have been attached with Exhibit S or included elsewhere in the application form. Please provide the Division with these documents.

Your application will not be considered filed until the information listed above is received and found sufficient to begin our review. A decision date will be established ninety (90) days from the date of receipt of all of the requested information. Additionally, if you have already published notice you will need to republish notice, after the Division considers the application submitted. Republication must occur once within ten (10) days of the submittal date. We will notify you when you should initiate republication of your notice. The final date for receiving comments is ten (10) days after the date of publication or the next regular business day.

You have sixty (60) days from the above date to submit all necessary documents that the Office needs for an application to be considered filed. If, at the end of the sixty day period, the application has not been determined to be filed with the Office, the Office shall deny the application and terminate the application file. This letter shall not be construed to mean that there are no other technical deficiencies in your application. The Division will review your application to determine whether it is adequate to meet the requirements of the Act after submittal of all required items.
