The New Horizon Mine office is located at 27646 West 5th Street, P.O. Box 628, Nucla, Colorado. The permit area contains tracts of land located in Section 6, Township 46 North; Range 15 West; Section 1 Township 46 North, Range 16 West; Section 36 Township 47 North, Range 16 West, of the New Mexico Principal Meridian, Montrose County, Colorado. The above mentioned tracts of land are shown on USGS 7.5 minute Nucla Quadrangle map.
