Hi Nicole,

Thank you for notifying the Division on your plans to reclaim the Red Jasper Granite site (Permit No. M-1982-200) by entering into final reclamation. As the last Temporary Cessation period ended on April 1, 2022, Rule 3.1.3 requires all reclamation to be carried to completion before **April 1, 2027**. You will need to continue to comply with the Annual Report, Map, and Fee requirements, due each year on November 19th, until the permit is released and the bond is returned. Once the site has been reclaimed and an adequate amount of vegetative cover has been established, please submit a Request for Final Release (<https://drive.google.com/file/d/1S7XBbituMeKorliHjEgJhnNCwjJhdZWl/view>). An inspection will occur following the request to evaluate the reclamation work.

I am attaching the original and amended reclamation plans so you can review the approved details outlined in the DRMS permit. You may also want to contact the BLM to see if they have any suggestions on completing work at the site. Please let me know if there are going to be any changes with the approved plan as they may need to be proposed through a Technical Revision first.
