2.03.5 COMPLIANCE INFORMATION

Neither NECC nor any of its affiliates or persons controlled by or under common control with it, has had a mining permit for surface coal mining operations suspended or revoked within the last five years. Nor have any such entities forfeited a mining bond or similar security deposited in lieu of a bond in connection with any surface mining operations.

NECC received a notice of violation on October, 22, 2021 (CV-2021-001), the violation was terminated on September 21, 2022. NECC prematurely reconstructed a light use road to a haul road before getting approval from CDRMS. The violation was abated via the approval of TR-76.
