Dear Mr. Lennberg:

In accordance with COLORADO DEPARTMENT OF NATURAL RESOURCES Division of Reclamation, Mining and Safety HARD ROCK METAL MINING 2 CCR 407-1, 7.2.3 (2)(c), Grand Island Resources (GIR) hereby respectfully requests approval by the Division to extend the required 180 days for submittal of the application by the Operator (7.2.3 (2)(b)), for a period of 1 year.

GIR requests the extension given that the preparation of the Environmental Protection Plan and Emergency Response Plan would be based on the following on-going work

- 1). The groundwater and surface water quality data currently being collected as part of Technical Revision 10 (TR-10);
- 2). Development of a Groundwater Conceptual Model, and;
- 3). Time to engage Third Party Consultants to develop related studies, process analytical data and assess potential environmental impact, prevention, and management strategies as well as preparation of an Emergency Response Plan.

GIR looks forward to the Division's approval of the extension and to continued communication with the Division on the topic.
