RE: Hayden Gulch Loadout; C-1992-081; 2022 Annual Reclamation Report Review

Dear Ms. Kawcak:

The Colorado Division of Reclamation, Mining, and Safety (Division) has received and reviewed the 2022 Annual Reclamation Reports (ARR) for the Hayden Gulch Loadout (HGL) for compliance with Rule 2.04.13. Below is a discussion of the Division's review. **Bolded items are issues that the Division requests Twentymile Coal, LLC. (TC) to respond to by March 27, 2023.**

On the ARR form, "Last Year's Cumulative Total" columns need to have the values entered from the previous year's ARR. Last year's ARR (2021) reported a cumulative total of 41.0 acres seeded (permanent). This year's ARR (2022) reported a cumulative total of 38.7 acres seeded (permanent). Please clarify the discrepancy of 2.3 acres in the 'acres seeded (permanent)' section of the form.

Rule 2.04.13

- (1) The reports were received by the Division on February 15th 2023. The deadline each year is February 15th.
 - a. The name and address of the permittee and permit number is listed on the cover letter of the ARRs and the ARR forms submitted.
 - a. The cover letter indicates HGL disturbed 0 additional acres in 2022. The total disturbed acres is 202.1 Non-permanent acres (159.6), acres backfilled (42.5), and acres added (0) add up to the total disturbance 202.1 acres.
 - b. The report indicates that no backfilling and grading activities were conducted in 2022.
 - c. The report indicates that no topsoil was applied in 2022.
 - d. The report indicates that 10.5 acres were seeded in 2022.
- (2) HGL indicated they conducted weed control spraying in September in 2022.

It is noted that the Division interprets the submittal date of February 15, or other such date as agreed on identified per Rule 2.04.13(1) as the complete and accurate submittal of the Annual Reclamation Report covering the previous calendar year for all areas under bond. As such, please provide all responses to the Division's review of the Annual Reclamation Report within thirty (30) days of the date of this review.
