Hey Jacob,

I received an email today from Brent indicating that he is no longer on the Mine Plan of Operations for the USFS nor the claim ownership through BLM. I am guessing he sent me the email as he is listed as an AF contact type of your ePermitting account which means he got a copy of the emailed 30-day notice that just went out for the annual report, map and fee due on/before March 4th. You can either update your ePermitting account to remove Brent by clicking on Change of Contact Form within your ePermitting Account's hyperlinks list, selecting Additional Annual Fee Contact, and then clicking "Remove" OR you can submit a simple request to the Division to deactivate his contact information under your permit's correspondence. If you go with the latter, you can include this request within the narrative of the revision discussed below.

This split of partnership was originally discussed more than a year ago and now that things have settled out, we should now make changes to the permit to reflect what has changed since the permit was applied for and issued. Moving forward, you need to update your permit to reflect the changes to Exhibit G - Source of Legal Right to Enter. Your original permit application listed you and Brent as the subsurface owners of record of the affected lands which also matched the names on the MPO with the USFS which serves as the surface portion of Exhibit G. This type of change will need to be submitted as a Technical Revision to your permit and fortunately, for a 110(1) permit there is no TR application fee. There is a TR cover sheet available on our website (<https://drive.google.com/file/d/1IkL1q-sDhhsorQnHsc0DMrE3FprUSfUh/view>). Please either leave the bottom blank or write in "110(1) - no fee". Accompanying the TR, you can provide your own narrative describing the update to permit and include updated Exhibit G documents (something from BLM which shows you are the sole entity of the claims and the same from the USFS regarding the MPO). You can also include a request to change the operation name within the TR, if you would like as the current name is "Ulrich - Revedo Mine". Lastly, as discussed above, you can request the change of contact on the annual fee copy too. You are welcome to submit the TR and documents all through email to me if that makes it easier.

Hello Jacob,

For DRMS, once Brent has received authorization from the USFS (a conditionally approved MPO) he can submit his own State mining permit for this project. The process of removing Mining Area 3 from your permit all depends on if it has been disturbed under M2019057 already. If the site is undisturbed, you can submit an Acreage Reduction to carve

this area out of your permit and then it will be up to Brent to permit his project. If the area has already been disturbed, Brent will need to permit the area and once his permit is issued (approved and bonded), you can then request an Acreage Reduction on your permit to carve out the overlapped areas.

Brent may call/email me if he has any questions regarding permit types, forms, application and annual fees, permitting process, Rules etc.
