***RE: Collette Property, File No. M-2022-051, Receipt of Incomplete Construction Material Special (111) Operation Reclamation Permit Application Package***

Dear Mr. Hurley:

On Wednesday, March 01, 2023, the Division of Reclamation, Mining and Safety (Division) received the Construction Material Special (111) Operation Reclamation Permit Application package for the Collette Property, File No. M-2022-051. A preliminary review of the information received determined that the following items must be received before the Division can consider the application submitted and technical review can begin:

1. No mining Plan Exhibit was included as required by Rule 6.3.3
2. Exhibit F- List of other permits required. Exhibit page included but no information provided to indicate what/if any other permits are required.
3. No Affidavit of Posting Notice (sign) was included as required by Rule 1.6.2(1)(b)

Additionally to expedite the review process the Division has conducted a preliminary adequacy review of the application materials submitted. The Division determined that the following issue(s) of concern shall be adequately addressed before the application can be considered for approval.

4. The application form question No. 9 is missing the quarter/quarter location description.
5. Please clarify the site name. Cover letter states "Collette Property Borrow Area" application form says "Collette Property". What site name would you like filed with the Division?
6. Exhibit A Location Map, and Exhibit E Mining and Reclamation Plan Maps are not signed by a registered land surveyor, professional engineer, or other qualified person or dated as required by Rule 6.2.1.(2)(b) and (c)
7. "Grass" is too vague to meet the requirements of Rule 6.3.2(a) for a description of vegetation. Please provide a description of the general species and composition present prior to mining
8. Pursuant to Rule 6.3.4(e) Provide a reclamation cost estimate



9. Exhibit G- Legal Right to Enter. Agreement is include but is not notarized as required by Rule 6.3.7
10. Exhibit K-Government Contract. The location description of the CDOT contract provided appears to be for a different section of Highway 13 not the area for which this pit is providing material. Please verify this is the correct CDOT contract.

YOUR APPLICATION WILL NOT BE CONSIDERED SUBMITTED UNTIL ALL THE INFORMATION LISTED ABOVE IS RECEIVED AND FOUND SUFFICIENT TO BEGIN OUR REVIEW. A DECISION DATE WILL BE ESTABLISHED 15 DAYS FROM THE DATE OF RECEIPT OF ALL OF THE REQUESTED INFORMATION.

You have sixty (60) days from the above date to submit all necessary documents that the Office needs for an application to be considered filed. If, at the end of the sixty day period, the application has not been determined to be filed with the Office, the Office shall deny the application and terminate the application file.

This letter shall not be construed to mean that there are no other technical deficiencies in your application. The Division will review your application to determine whether it is adequate to meet the requirements of the Act after submittal of all required items.
