Re: Notice of Informal Public Meeting for March 16, 2023 Application for 112 Construction Materials Reclamation Permit Application with Public Objections; Raptor Materials LLC; Two Rivers Sand, Gravel and Reservoir Project; File M-2022-013

Dear Party or Interested Person:

The Division of Reclamation, Mining and Safety (Division) appreciates you taking time to participate in the review process of the above referenced permit application. The application for Two Rivers Sand, Gravel and Reservoir Project was filed with the Division on April 18, 2022 by Varra Company Inc. (the applicant was subsequently changed to Raptor Materials LLC). The review period for the application is currently scheduled to close on March 31, 2023.

The application will be scheduled for consideration by the Colorado Mined Land Reclamation Board (Board) at the April 19-20, 2023 Board meeting. A pre-hearing conference will be held after the Division has issued its written recommendation on the application and at least ten calendar days prior to the formal Board hearing. Official notice of the date, time, and location for the pre-hearing conference and formal Board hearing will be provided to all parties and interested persons who are receiving this notice.

During the informal meeting, the Division will present the following information:

- Explain the reclamation permit application review process
- Identify the issues which the Mined Land Reclamation Board has statutory jurisdiction to address under the Colorado Land Reclamation Act for the Extraction of Construction Materials, C.R.S. § 34-32.5-101, et seq.
- Describe party status
- Explain the pre-hearing conference process
- Explain the formal Board hearing process.

During the meeting, attendees will have the opportunity to ask process-specific questions of Division staff. However, individual speaking times may be limited due to time constraints.

Any person who submits a written comment during the public comment period for the application has standing for party status. Party status is subsequently maintained by participating in the pre-hearing conference and formal Board hearing. However, the public meeting to be held on March 16, 2023 is informal and has no bearing on party status. Parties are not required to participate in the informal meeting on March 16, 2023 in order to maintain their party status.
