On December 2, 2022, the Division of Reclamation, Mining and Safety (Division) received your request for a full/final release of 32.25 acres for the Kokes Gravel Pit, File No. M-1978-249. The Division will conduct an inspection to verify that reclamation has been completed in accordance with the approved Reclamation Plan and the Reclamation Performance Standards outlined in the Construction Materials/Hard Rock Rules.
