This message is to follow up on the phone conversation we just had this morning.

1. Since you've been having email problems recently, you may need to update your ePermitting account with your new email address. To do that please complete an [ePermitting Administrator Change Form](#) and we will update your information. Once it is updated, you will receive an email with instructions on how to get logged in. Requests are usually processed within thirty minutes, but please allow up to two business days.

2. The annual report for M1980003 was due on January 23rd, but has not yet been received by the Division. If a paper copy was sent it may not have been delivered correctly, or it may have been returned. In either case, the 60 day grace period following the due date will expire at the end of next week so it would be ideal if we can get the issue resolved before then.
