Good Morning Eric,

Once Broomfield was made aware of the monthly groundwater monitoring and reporting requirement on March 2nd they asked us to monitor the wells at the site. I went out on March 3rd to monitor Wells 1 through 10 and back out again on March 6th to monitor Wells 11, 13, 15, and 17 once you provided me with the map of their locations. The updated spreadsheet that Pioneer had been using is attached and with some added graphs.

4 wells included in the spreadsheet were not measured due to being missing/destroyed:

- MW-5 was noted as missing by Pioneer on 4/29/2017,
- MW-6 was located in a nearby pile of rubble at the Lupton Meadows Site (picture included),
- MW-8 was not able to be located at the southern end of Parcel 130918001004 across WCR 25 from the Site,
- MW-11 was a PVC riser with no metal monument and the riser was found lying in the grass close to the mapped location (picture included).

Depth to groundwater is scheduled to be measured again on March 31st and reported to the Division.

As we discussed a couple weeks ago, the City and County of Broomfield is submitting the attached Technical Revision to discontinue the monitoring requirement at the site. Hard copy is going in the mail today with the check.
