Nikolaus Arnusch, who's address is 34527 County Rd. 6, Keenesburg, Colorado 80643 and who's phone number is (720) 383-2051, has filed an application for a Regular (112) Construction Materials Operation Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed mine is known as Arnusch Gravel Pit #3, and is located at or near Section 23, Township 1 North, Range 63 West of the 6th Prime Meridian. The proposed date of commencement is April 2023 and the proposed date of completion is December 2027. The proposed future use of the land is pastureland.
