Can you provide me with responses to the following questions so we can determine what, if any, permitting is needed for the Lime Storage Pig:

- 1. You mentioned on the phone that the tank is owned or at least provided by the lime supplier and the purpose of this tank is to provide additional capacity for when the current ROM lime silo is emptied prior to resupply. Can you confirm these details or correct the Division's understanding of the proposal? We will be renting the lime storage pig from our lime transporter.
- 2. What is the anticipated timeframe for the need of this additional lime storage? Possibly to 2025.
- 3. In a scenario where lime is left in the storage tank at the time of when the tank needs to be removed from the site, does the supplier take this remaining lime back with the tank or does it need to be disposed of properly? The lime will be used before the pig is transported off site. Any residual lime left will go back with the lime transporter.
