ADDITIONAL INFORMATION NEEDED

Dear Mr. Spielman,

The Spielman – Goldpark King #2 Notice to conduct exploration activities on the Goldpark King #2 placer claim in Park County, Township 9 South, Range 76 West, Sec. 3 NE was received on March 21, 2023. The Notice has been assigned Bureau of Land Management (BLM) case file number COC-080911. Please refer to this number in future correspondence concerning this operation.

Consistent with the surface management regulations at 43 CFR 3809.311(a), the BLM has reviewed the Notice to determine if it meets the content requirements at 43 CFR 3809.301(b). Based on this review, the following information is still needed in order for BLM to continue processing the Notice.

1. Provide a Stormwater Discharge Permit or document stating that a permit isn't required for this operation from the Colorado Division of Public Health and the Environment.
2. State the source of your determination that it's likely that groundwater would be encountered during this exploration.
3. Provide a map or satellite image with a more detailed depiction of the exploration site, including the road and trenches' proximity to the perennial stream.
4. List the contents of spill kit(s) that would be kept on site in case of a gasoline or lubricant spill.
5. State the total volume of lubricants to be kept on site.
6. Describe any signage or other safety features to be used on site.
7. State the source of the pre-existing road.
8. State the maximum number of days that the camp trailer would be on site.
9. Explain where and how any waste, including the proposed port-a-potty, would be disposed of off-site.

Until a complete Notice is filed with this office, the BLM is unable to determine that your proposed operations will not result in unnecessary or undue degradation as defined under 43 CFR 3809.5. In addition, we are unable to make a determination as to the amount of the required financial guarantee.

Please submit the required information at your earliest convenience. Until we receive this information your Notice cannot be processed and the proposed exploration activity is not to take place. If you have any questions, please contact Sophia Brooks-Randall at 719-269-8750.
