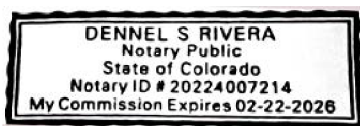

The proposed mine is known as the Hayden Gravel Pit, and is located at or near Section 12, Township 6N, Range 88W, of the 6th Prime Meridian.

The proposed date of commencement is October 2023, and the proposed date of completion is October 2046. The proposed future use of the land is general agriculture.
