Re: Colowyo Coal Mine (Permit No. C-1981-019) Technical Revision No. 159 (TR-159) Adequacy Review

Dear Mr. Tennyson:

After reviewing Colowyo Coal Company L.P. (Colowyo) Technical Revision No. 159, the Division has the following adequacy comment:

1. The Division has performed a cost estimate to determine the associated disturbances with TR-159. This includes the regrade of topsoil placement for the proposed East Pit access roads and Section 3 Pond borrow area along with reseeding costs. Additionally, the Division calculated the cost for the demolition of the two culverts associated with the proposed roads. The total amount of this estimate is **\$26,097.00** (see attached cost estimate). The Division's cost estimate is consistent with previous cost estimates approved by both the Division and Colowyo. The Division respectfully requests a response from Colowyo with any questions regarding the cost estimate or an acceptance of the Division's estimate.
