Answers:

#1 - The T-shape trenching plan will be set up in the same way as previously described and depicted in June 1st Project Update (dimensions/alignment of trenches and overall disturbance footprint), and will be located north of the Park Gulch drainage trace.

#2 - The minimum distance between the southern edge of our disturbance (where the stormwater/sediment containment berm will be constructed) and the northern edge of the wetlands is ten (10) feet.

#3 - The dimensions of the stormwater/sediment containment berm will be 1-2 ft in height and 2 ft in width, and will extend the full width of our trenching affected area.

I hope this answers your questions satisfactorily.

Hello Nicole and Charlie,

I have received your June 4th Memo regarding updates to your trenching plan. Can you please address the following three items to help clarify your updated plan:

1. Will the T-shape trenching plan be set up the same as previously described and depicted in the June 1st Project Update (dimensions/alignment of trenches and overall disturbance footprint), but will now be located north of the Park Gulch drainage.
2. Please provide the minimum distance between the southern edge of your disturbance (where the stormwater/sediment containment berm will be constructed) and the northern edge of the wetlands. The Division's file needs to reflect what this buffer distance will be.
3. Please provide the dimensions of the stormwater/sediment containment berm.

As for approval of your NOI, the Division is waiting for Notice of Filing Deficiency Item #2 to be addressed. You will need to obtain BLM authorization in accordance with Rule 5.1.2(d)(vi).

I spoke with Elliott Russell this morning; he will send me an e-mail today listing several items the DRMS wants addressed before approving our NOI. He will, I believe, include 2 items needed from the USBLM Re your approval of our plan:

1. A revised seed mixture for reseeding areas impacted by our program; I asked Sophia for USBLM input on this, but didn't receive a recommendation from her.
2. USBLM approval of our plan revision eliminating the 2900-ft access road and accessing the trenching sites "overland."

I expect he will send you an electronic copy of his e-mail to me; but this is to provide you a "heads up" ahead of that, to expedite final approval of our trenching program, hopefully today or tomorrow, May 31st.
