RE: Buster Quarries - File No. M-1981-107 Technical Revision (TR-1), Reclamation Plan Update, Division Adequacy

Dear Mr. Buster:

Your Technical Revision application for the Buster Quarries 112c Construction Materials Reclamation Permit was filed on June 2, 2023, and a decision date has been set for July 3, 2023.

The following adequacy items must be addressed before the Division can approve this application.

- Your submittal for TR-1 included two maps. Please explain the purpose of the map with the reclaimed contours. This map has no title block or any of the other necessary information required on exhibits. Please see Rule 6.2.1(2) in the "Minerals Rules and Regulations of the Colorado Mined Land Reclamation Board for the Extraction of Construction Materials" (effective July 15, 2019). It is possible that this map is not necessary; the permit files for this site include a similar map that is labeled Exhibit F.
- 2. Regarding the submitted map that is titled "Map 2," several aspects of this map need to be improved.
 - a. The title must say that this map is part of Exhibit F.
 - b. The Division recommends that the text on the map be cleaned up to remove extraneous language such as reference to the technical revision. Also, it would be beneficial to include on the map an explanation of the terms primary and secondary.
 - c. The timeline for reclamation of each of the disturbed areas need to be identified, per Rule 6.4.6(a). This should include reclamation that has been performed in the past and estimated years for reclamation in the future. The years of future reclamation can be general, for example, "By the Year 2035."
 - d. Per Rule 6.2.1(2), the map must include the name of the applicant (ELB Stone, Inc.), the signature of the preparer, the date the map was prepared, and the permit boundary.
 - e. The hatching on the map must match the legend. For example, the legend does not include black horizontal hatching.
 - f. A scale bar should be included on the map.
