Since the submission of that last letter we have pulled the plastic piping and caps and sealed the tops of the holes with concrete mixed with the drill cuttings from the holes.

This letter is to inform you of the drill hole abandonment for 14 drill holes drilled on NOI P-2019-013 in March of 2020. The company made 7 small drill pads roughly 10' x 20' and drilled 2 - 300' holes from each pad. None of the holes intersected artesian water flows and remain dry. To seal the holes a 4" pipe with a cap was placed in each hole. This will allow us to go back and survey the hole at a later point.
