During 2022, the only work o the project was that authorized by the NOI. That consisted of opening up 5 old pre-law drill pads and associated road plus establishing 6 new pads with only minor disturbance on relatively level native ground. The new pads were accessed by cross-country travel over terrain similar to where the pads were made. All pads and roads were placed where authorized. Lastly, after drilling, the drill holes were plugged and abandoned as per the permit, the site recontoured, seeded and bedded with an approved seed mix and manner.
