The project was an exploratory drilling program approximately 20 miles south of the intersection of State Highway 141 and State Highway 145, south of Nucla, San Miguel County, Colorado. Access from Colorado State Highway 141 to the site is via Road 23R, south of State Highway 145. Exploratory drilling occurred in and near an area known as Klondike Basin. This project was part of a small exploratory drilling program where the majority of disturbance occurred on BLM land under P2022-005. Activities under P2022-007 consisted of only temporary access road construction and maintenance and reclamation activities. 376 linear feet (0.13 acres) of new temporary access routes were constructed between August 1st and ended on September 15th. Reclamation is ongoing and project received 70% reclaimed during the inspection on October 25th 2022.
