Prospecting activity that occurred during the 2022 mining season includes a modification that opened a new site, Site 2 with a 1 acre, 20 test pit disturbance. 12 of the 20 test pits were mined fully reclaimed and seeded. Along with the reset of the pits on Site 1 back to 10 total pits. 0 test pits of the 10 test pits mined on Site 1. The ponds were enlarged the new dimensions of all 3 ponds are 20' wide each. The ponds and wash plant are a closed circuit system. The ponds and wash plant are fenced in to protect wildlife and grazing cows. The fence is temporary and can be removed quickly. The pits are marked on the map provided. No roads or structures were added to the mine site. All driving was done on existing 2 track. A new deposit for Site 2 was paid through BLM in the amount of \$2,049.00 on 04/06/2022.
