## TO WHOM IT MAY CONCERN:

This office is Colorado counsel for Intact Insurance Surety Group ("Intact"), the successor and attorney-in-fact of Guarantee Company of North America USA.

Intact and its bond principal, Crossfire Aggregate, have mutually agreed that the referenced Guarantee Company of North America USA bonds for M-2015-001 (Bonds Pit, La Plata County) and M1992-054 (Ignacio Pit, La Plata County) will be promptly replaced by bonds from a different but fully qualified surety. It is my understanding that replacement bonds for both LaPlata County pit locations have been submitted to the Colorado Division of Reclamation Mining and Safety ("DRMS") for review, approval and acceptance.

This letter is intended to formally notify the Colorado Division of Reclamation Mining and Safety of Intact's intent to cancel its financial guarantee/reclamation bonds numbered 75034066 and 75034067.

Assuming that DRMS accepts Crossfire's substitute instruments, we anticipate that both of the above Intact bonds will be released and exonerated by DRMS.
