Comment/Objection Narrative *

Regarding the TR-6 and the February 2023 adequacy review report from Tetra Tech, changes in historical return water flows and forcing tailwater to run east has created problems with lost crops due field saturation. 3. Page 10 of the reports states that MM will monitor wells HO-1 and HO-11 quarterly during reclamation after mining is complete. We are concerned that quarterly monitoring may not identify when groundwater levels in HO-1 and HO-11 are above the 4' trigger for 2 consecutive months, necessitating the installation of the drain. The Mitigation Section 2.3 of the report, and the submitted drain design does not address how MM will either mitigate or compensate LRM or other neighboring properties for damages to lost crops and the inability to farm their properties due to ground saturation.


