## Re: Keenesburg Strip Mine (Permit No. C-1981-028), Second Review of 2022 ARR

Dear Ben:

I have reviewed your response (letter from April 20, 2023) related to the 2022 Annual Reclamation Report (ARR). Regarding the ARR form with acreage values, the following items need to be addressed:

- 1. The dates on the form look to be erroneous. The ARR year at the top is 2021 rather than 2022. Also, the footer has a 2019 date. Please update the dates or explain this apparent discrepancy.
- The values under the Acres Seeded section need to be revised. Per the instructions for this form, the areas that have been Phase III released should <u>not</u> be subtracted. The values in this section of the form should reflect the entire life of the mine.

The changes for the reported year (2022) should be included in the added and subtracted columns. In general, additions and subtractions may be the result of actual seeding in the reclamation year, the seeding timeframe becoming 10 years and greater (was 9 years and less), and/or corrections (e.g., due to more accurate mapping). It appears to the Division that the only changes that should be reflected in the 2022 form would be corrections. There was no seeding in 2022 (other than reseeding), and no areas changed from 9 years to 10 tears since seeding.

Finally, the totals in the Acres Seeded section should be accurate.
