On July 6, 2023 the Division of Reclamation, Mining and Safety concluded its review of the Technical Revision application submitted to the Division on July 5, 2023, addressing the following:

An area within the Heintzelman Project (Pit 116), adjacent to the existing residence on the west side, has been affected by grading activities that were not described in the original Extraction and Reclamation Plans for this site. This Technical Revision will update the Extraction and Reclamation Plans.

The decision reached by the Division is: approve. The application materials were sufficient, and the Division approved this TR.

It should be noted that some of the information in the application for TR-2 is not correct. Several acreage values were listed as changing, including the permit area. No changes to the permit area or other values are being made with this technical revision.

The terms of Technical Revision No. 2 approved by the Division are hereby incorporated into Permit No. M-2009-018. All other conditions and requirements of Permit No. M-2009-018 remain in full force and effect.
