Since Pioneer is assigning all their obligations for the Fedinec Pit to Camilletti LLC, the BLM Contract COC-76325 and the CDRMS Permit Number: M-1977-057. The BLM Contract has been updated to reflect the assignment to Camilletti LLC.

Fedinec Pit: There is approximately 2.0 acres of actual mining area (rock out crop), remaining 28.0 acres consist of 2.0 acres mined out and remaining 26.0 acres used to stage the rock screen for sorting, a crusher to reduce some of the rock to gravel and area to load trucks out. Th 28 acres are all on Camilletti Private Surface, with only the original 4.0 acres of Federal Minerals under the mining plan for royalty consideration.

Payment is required before any material is removed. Please make payments to this office with reference to COC-76325, submit the amount (tons) to be remove accompanied with the Royalty payment. Please include approximate dates of operation for the removal of these tons.





- The Permittee and /or Designated Operator will conduct Pit Operations and Reclamation operations per the CDRMS Approved Mine Plan under Permit Num: **M-1977-057**.
- The Permittee and /or Designated Operator will maintain the Reclamation Bond held by CDRMS, that is based on the Reclamation Plan under CDRMS Permit Num: **M-1977-057**.
- Ensure the Permit Boundary is properly marked and is visible for inspection and signage is current.
- A copy of the scale certification will be submitted once a year with renewal of the scale certification.
- Permittee or Operator will submit a monthly spread sheet detailing the production and sales. Copies of weight tickets from a certified scale will be submitted monthly, including the vehicle license number, location of sale, date, and gross tare and net weights.
- Water will be used to suppress dust as necessary.
- Erosion control methods will be employed as necessary to control run off.
- No hazardous materials/hazardous wastes, trash or other solid waste shall be disposed of on site. If a release does occur, it shall be reported to this office immediately. Permittee is responsible for disposing of all debris in accordance with state and federal regulations.
- Disturbed areas will be monitored for noxious weeds and operator will be responsible to control these weeds during mining and reclamation thru the term of the CDRMS permit **M-1977-057** and the Bond release period.
- Permittee or Operator is responsible for all suppression costs for any fire resulting from their operations and practices.
- The permittee is required to use the reclamation practices necessary to reclaim all disturbed areas. Reclamation will ensure surface and subsurface stability, growth of a self-regenerating permanent vegetative cover and compatibility with post land use.
