Good afternoon Pat,

As was previously communicated in the attached June 2, 2023 letter and multiple emails from myself and my predecessor Mike Johnson (over the course of many years). We need a completed SF-299 form as a proposal for road right-of-way access on a non-motorized road and to remove unauthorized items from National Forest System land at the entrance to the Rip Van Dam. We will need written proof that Eric Harms is allowing your company to cross his private parcel to access the entrance to the Rip Van Dam mine and haul unauthorized items out.

We also asked for a reclamation plan that will address all of the surface damage on National Forest System land. I cannot provide you with a date for a Special Use Authorization (SUA) permit, because I do not have a complete proposal for road right-of-way access and a reclamation plan that addresses all of the surface damage. Let me know when you can get these materials together and I will process them.

Good afternoon Pat,

K&B Mining Company, LLC must comply with DRMS's February 9, 2023 signed Board Order. Please see the attached map and information from the U.S. Geological Survey. The entrance to your Rip Van Dam mine is currently located on federal National Forest System (NFS) land. Likewise, there are some National Forest System Roads (NFSR) sections off of the 287-1, 287A, and 287B area which are not illustrated on the attached Motorized Vehicle Use Map and are not authorized for motorized vehicle use. Based on the information in the case file for this site, in 2022 the private property owner for the Higbee Placer reported to the DRMS and USFS that the miners were accessing a section of 287.1 on his private property as well as an area of 287.1 that the USFS closed off to motorized vehicle use to transport items up to the main entrance of the Rip Van Dam site.

Rip Van Dam Mine (MRDS #10018036) AU, AG (usgs.gov)

The USFS is offering to work with you to obtain a Special Use Authorization (SUA) permit for motorized vehicle use for the portion of 287.1 that is currently marked as "road closed" and also to work on the cleanup of items on NFS land. If your staff/reclamation team plans to use access via James Canyon Drive and past the Higbee Placer owner's private property and new gate again. Then the USFS needs proof that the private property owner has authorized you to cross the portion of 287.1 that is on his private property before we can process a SUA permit for site access. I am also aware that you might try to get access to James Canyon Drive via the 768 James Canyon Drive private property or Franklin/Steamboat Lodes. For removal of unauthorized items from NFS land and the required reclamation work.

Has K&B Mining Company, LLC submitted a complete reclamation plan to DRMS? We have not received any information regarding proposed site access or a complete SF-299 form for a SUA from the USFS.

What is your game plan here?

Thanks for the follow-up.

I am not quite sure who I am dealing with or who has jurisdiction in this matter. I am a private land owner over which FSR 287-1, 287A, and 287B traverse over thousands of feet.

In the past 90 years, neither I nor the previous owner have ever had access problems to our properties.

K & B Mining LLC, licensed in Colorado on February 2, 2014, as a foreign company was the Operator and NOI permit holder for File No. P-2013-019 for Telluride Gold LLC, a Texas Company that had leased the mining claims from me. Telluride Gold LLC was dissolved on December 31, 2019. The remaining assets at the lease site belonging to Telluride Gold LLC were sold in October 2019 as necessary for the dissolution of the company. These assets exceeding \$160,000.00 were taken from the site in November 2019 when vandals posing as repo hires to locals, torch-cut locks to gates, storage buildings, and portal steel gates.

After December 31, 2016, K & B Mining LLC was dormant and performed no prospecting or other reclamation activities on the site. K & B Mining LLC's reclamation bond with DRMS (Bond No. 0723300273 in the amount of \$11,243.00) is still posted with DRMS.

My role with K & B Mining LLC began on December 31, 2016, by way of a Membership Purchase Agreement between Farr, Telluride Gold LLC, and others when I purchased a controlling interest in Telluride Gold LLC.

Dear Mr. Farr,

On April 10, 2023, K&B Mining Company, LLC associate David Brown contacted the Boulder Ranger District regarding access to the Rip Van Dam Lode (MS 241A) mining claim. The Boulder Ranger District notified Mr. Brown that Forest Service (FS) lands staff were reviewing the information in the case file for this site.

The K&B Mining Company, LLC FS-approved Plan of Operations expired at the end of 2015. Therefore, the road use, operations, and site storage allowed under that Plan are no longer authorized. Several items that were not authorized under the previous Plan were found to be illegally stored onsite. These items must be removed. It was also noted that heavy surface damage is visually apparent at the Rip Van Dam Lode mining claim. This includes damage to a cliff side that has caused soil to fall into a stream area below the cliff and removal of large trees, both at the south entrance to this mining claim.

In addition to the USFS's review of the case file information for this site, the USFS and Colorado Division of Reclamation, Mining and Safety (DRMS) met on April 25, 2023, to compare information regarding the Rip Van Dam Lode mining claim and come to consensus on a path forward.

On February 9, 2023, the DRMS's Mined Land Reclamation Board issued a signed Board Order. This Board Order was issued for failure to maintain legal right of entry and for failure to timely reclaim the affected lands within five years of completion of prospecting activities. The Board Order directs K&B Mining Company, LLC to obtain legal right of entry and to complete reclamation of the affected land. The operator, K&B Mining Company, LLC, has until August 8, 2023, to comply with the Board Order.

K&B Mining Company, LLC, also needs to submit a plan of operation for the outstanding reclamation work to the DRMS for their review and approval.

In order to facilitate site reclamation, the FS will work with K&M Mining Company, LLC, to issue a Special Use Authorization for motorized vehicle use on National Forest System Roads 287.1, 287A, and 287B. Please complete the enclosed SF299 form and submit it to Lauren Kryszczuk at the address above or electronically to lauren.kryszczuk@usda.gov. The permit does not authorize access across private land which will need to be addressed through other channels.

K&B Mining Company, LLC is required to acquire legal access across private land and provide evidence of this access to the USFS before the USFS can process an SF299 proposal for Special Use Authorization. If evidence of legal access across private land is not provided to the USFS, the USFS will not be able to screen and process an SF299 proposal.

In addition, K&B Mining Company, LLC needs to submit a plan of operation for repairing the surface damage to USFS land caused by the mining operations that took place at the Rip Van Dam Lode site.

No further activities or mining operations will be considered by the Forest Service until these items are addressed.
