Prospecting is done both surface/subsurface by hand sampling. Mine building is a locked temporary shed. The adit is locked by 2 hooded locks on a steel grate. Access to trestle is blocked by a wood barricade and sign. There is a hooded locked gate on the road to the mine. Mine and building maintenance and ventilation is ongoing. Warning signs are posted.
