Dear Hannah Dutrow,

On July 20th, 2023, the Division of Reclamation, Mining and Safety (Division) received an "Is It Mining?" questionnaire regarding the above referenced site. According to the questionnaire, topsoil will be extracted from private agricultural fields to facilitate the construction of a new pond and silage pad for use by an existing dairy facility. The majority of the material excavated is proposed to be hauled off to other fields owned by the property owner or to a third-party. About 48.7 acres is proposed to be affected by the operation and you project about 75,000 cubic yards of material will be removed.

The Mined Land Reclamation Board has requested the Division make determinations as to the need for a Mined and Reclamation Permit. Based on the information provided in the questionnaire, the Division has determined a reclamation permit is required for this activity. The proposed activity meets the definition of a mining operation in accordance with C.R.S. 34-32.5-103(13). In accordance with C.R.S. 34-32.5-109(1) before engaging in a mining operation, an operator shall fist obtain a reclamation permit. Given the description of the operation, a 112c reclamation permit would be appropriate.

If you disagree with this decision, you may petition to appear before the Board during a formal public hearing for a Declaratory Order concerning this matter. Pursuant to Rule 2.5.2(1), the request must be submitted to the Board in writing and be received no later than seven days prior to the hearing. The written request must contain the information required pursuant to Rule 2.5.2(2). The next available Board hearing will be held on August 16, 2023. All hearings are held at 1313 Sherman St., Room 318, in Denver, Colorado 80203.
