One illegal prospect was discovered on Qui-Buc No. 4. We filled and reseeded this dig on 4 Aug 2023. There are other illegal digs on several of our claims but in the interest of minimizing impact, we will wait for reclamation for when we are doing authorized work at one of our mining permit sites or one of the pending prospect sites. We also reclosed an illegal road that had been closed by the Forest Service and reopened by rogue miners.
