#### **OBSERVATIONS**

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety normal monitoring program by Zach Trujillo. The Clay Pit No. 21 is a 112c permitted site that includes a total of 18.5 permitted acres. It is located approximately 20 miles northwest of Maybell, CO and is accessed from Moffat County Road 20. This site is on Bureau of Land Management (BLM) land however they were not present for the inspection. No representative for Moffat County was present.

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. The sign is located at the entrance of the permit boundary. T-posts have been placed to clearly delineate permit boundaries as well as a wire fence along the county road.

The site was inactive at the time of the inspection. One small material stockpile was located within the pit. No equipment or fuel is stored on site during the inspection.

The topsoil pile is located on the western side of the mine. The topsoil and overburden piles are clearly marked for designation. The topsoil pile was vegetated however limited coverage was present. No major erosion was observed on site. All slopes within the pit have been graded to approximately 3H: 1V or less.

This pit is operated by a government entity therefore no bond is required. No problems or violations were noted during this inspection.
