On August 8, 2023, the Division of Reclamation, Mining and Safety concluded its review of the Succession of Operator application (SO-1) to transfer the Rother Pit No. 1 (Permit No. M-1999-083) to Colorado Gravel LLC. The Division calculated the required financial warranty for this permit to be in the amount of \$66,131.00, in accordance with Rule 4.2.1.
