OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety normal monitoring program by Zach Trujillo. The Refuge Pit #1 is a 112c permitted site that includes a total of 43.4 permitted acres. It is located approximately 53 miles northwest of Maybell, CO and is accessed from Hwy 318. No representative of Moffat County accompanied the Division on the inspection.

The mine identification sign was located at the site entrance. The entire site boundary was inspected and affected area boundary markers are in place in compliance with Rule 3.1.12.

The site was inactive at the time of inspection with no equipment or fuel stored on site. All slopes in the mined area have been regraded to a 3H: 1V or less. Multiple stockpiles were observed along the pit floor.

Topspoil stockpiles were observed. All piles were marked with spare vegetation.

The reclaimed area of the site was marked to delineate from the portions of the mine not yet reclaimed. Some vegetation was visible and established however the cover density was minimal. Some thistle was observed in the reclaimed area and it is recommended that they are treated before additional establishment occurs. All reclaimed slopes have been properly graded to a 3:1 or less and are stable.

This pit is operated by a government entity therefore no bond is required. No problems or violations were noted during this inspection.
