Good afternoon, Rob.

I am writing to update you on weed abatement activities for permit M1978056.

Treatment for Noxious weeds has occurred. Treatment of Noxious tree species is still in process. We have spent about 3 weeks clearing trees, but this activity will need to continue into the fall and potentially into next summer.

I have attached a map. The red line denotes approx. mine boundary. The white area is the area that has been treated so far and the yellow areas are what still need treatment. Our treatment activities consist of cutting the trees down and treating the stump with Tordon per the labeled application specifications.
