Dear Mr. Russell,

Thank you for the Notice of filing deficiencies, in which you listed the items still needed for completing our application filing. We have reviewed it and offer the following information and set of enclosures as our response. The numbered items below correspond to the numbered items in your Notice.

1. Please see the revised application Page 3, on which the names of the surface and subsurface owners of the affected land have been corrected.
2. Please see the revised application Page 6, with the blank now left uninitialed.
3. Please see the image showing the posted notice with the signed and dated affidavit.
4. Requests have been made by the applicant to CPW for a wildlife statement (a copy of the request letter was provided in the application packet to DRMS). To-date, CPW has not responded in any fashion to the numerous requests made by the applicant for a routine "wildlife statement." This is an application deficiency item for which the applicant has no ability to compel CPW to provide said statement. As such, and understanding that this lack could indefinitely prevent the application from being considered "complete" and the technical review to begin, DRMS has allowed an alternative for the applicant to provide its own assessment of potential wildlife impacts. By allowing this assessment to be considered sufficient for purposes of application filing, CPW will be provided the opportunity to submit its own comments during the comment period. Please see the enclosed wildlife impact assessment developed by the applicant, based on CPW 2021 data.
5. Please see the additional page for the Exhibit D Reclamation Water Treatment.
6. Please see the additional page for the Exhibit D Reclamation Cost estimate.

7. Please see the additional page of Exhibit G, containing the notarized affidavit which affirms the ownership of the affected area and allowing right-of-entry to the applicant/operator.
8. Additional application materials (consisting of this set of enclosed completeness responses) were sent to the clerk and recorder on June 26, 2023 via certified mail and received there on June 29. We included a receipt for their office to sign and date, and a self-addressed stamped envelope to be returned, on which they would indicate date of placement. We received the signed and dated receipt on July 8, 2023, indicating that the additional materials were placed on July 3, 2023. We additionally requested that they provide us with the date of placement of the original application materials. Today we received the response from the clerk's office verifying the original filing date. That verification arrived via email, and will be forwarded to DRMS in a separate email. For the rest of the proofs of delivery and filing date, please see the attached information, showing that the copy of the additional materials packet was received at the county clerk and recorder's office, and the date of placement.

Exhibit B – Site Description – Rule 6.3.2(d)

Wildlife Statement

The applicant has researched the recent data (2021) made available by Colorado Parks and Wildlife (CPW) to assess whether there is the potential for impacts to the various wildlife species known to have any of their ranges in the location of this proposed operation.

The following is a list of species whose ranges are represented on Google Earth, by CPW 2021 data, as having any of their ranges overlapping the London Mine site.

Various fish and additional bird species are also shown by CPW as having ranges in the area of the London Mine site, though no further individual species or detailed range descriptions are provided.

As shown by the above list, there are numerous species known to potentially inhabit or migrate through the area of the London Mine, South Mosquito Creek, the Mosquito Range, Park County, or within this general elevation. There are no species within this area that are listed by CPW as being endangered or threatened, nor having critical habitat at this location.

In general, sites containing active mining (or, in this case, re-mining) can present various impacts from the disturbance. However, it is important to note several mitigating factors about this site and the proposed activities which reduce the potential adverse impacts. First, this is not an area of pristine wildlife habitat; this is an area of historic mining disturbance from which a significant amount of native vegetation has been removed and mineralized material exposed on the land surface. This has resulted in a wide area of diminished wildlife habitat value. Second, there are State-approved current and ongoing

water treatment activities being carried out (by this applicant) in the close proximity of this operation. These activities constitute intermittent human activity, which though temporary, may deter some terrestrial wildlife presence. But the broader picture shows us that these activities produce improved water quality for aquatic species (local and far downstream). The short-term and seasonal mining activities being proposed may similarly deter some wildlife, though the small site does not present any impediment to any migratory patterns, nor degrade any potential vegetation (there is none). Third, the proposed activities are designed primarily to improve water quality (for local aquatic biota and downstream users) by removing the most mineralized materials and stabilizing the remainder, but will also act to improve the local surface environment for future wildlife use and habitation.

Based on the discussion above, it is the belief of the applicant that the existing characteristics of the site, the proposed activities, and the temporary project timeframe all preclude this site from being considered essential habitat or presenting an impediment to a seasonally-significant migration area. Additionally, the applicant believes that after the few years needed to carry out the envisioned project, the stream water and the land surface will be left in far better quality and better able to support aquatic and terrestrial species.

MineWater LLC welcomes any further recommendation or comment from CPW, which could possibly help us to improve the reclamation of the affected area.

Exhibit D – Reclamation Plan – Water Treatment and Estimated Reclamation Costs

Water Treatment, Onsite Mineralization, and End Date

As specified in Rule 6.3.4(1)(f) and Rule 3.1.6(1)(f)-(h), the following information is submitted to clarify and reiterate: The site has been previously disturbed by mining and the only activities being proposed under this permit will be the removal of the most mineralized of the existing ore and waste rock. Affected materials that will be sorted and will remain on the site will be less-mineralized and will be placed and stabilized such that they will not cause offsite surface damage or infiltrate and adversely affect groundwater or surface water. The mineralized materials near the upper South London shaft will be removed so that they will cease to adversely affect groundwater (in the old South London workings). Effluent from the lower South London portal (immediately adjacent to the permitted area) is already being passively treated by the operator under the Consent Decree from CDPHE, and will continue to be. The operator has provided analyses demonstrating that the water quality has been measurably and significantly improved. The proposed surface activities to be carried out (identification and removal of the sources of contamination) will complement the ongoing water treatment program, and is expected to improve water quality even further. Per the requirements included in the Consent Decree, water quality treatment will continue with no reasonably foreseeable end date. However, proposed surface work will clean up onsite contaminant sources and greatly improve efficacy of existing water treatment.

Reclamation Costs

This proposed operation only includes removal, sorting and replacement of pre-disturbed surface materials, on previously-disturbed lands. All onsite roads and buildings will remain on the site as permanent features. There is no topsoil to replace or revegetation to establish.

Materials will be moved around the site by bulldozer, loader, and trucks. Sorting will be carried out by a stationary sorting plant that will be removed from the site at the conclusion of the operation. Since the applicant/operator of this permit is also the adjoining landowner, any equipment to be removed from the permitted area will be simply relocated to immediately adjoining land owned by the same entities.

At any point in the operation, reclamation tasks will involve removing mobile equipment and sorting plant, and reshaping stockpiles and existing dump surfaces.
