



## PUBLIC NOTICE

MineWater LLC, 9233 Park Meadows Drive, LoneTree, CO, 80124, 720-883-6700, has filed an application for a Limited Impact (110d) Designated Mining Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Mined Land Reclamation Act. The proposed mine is known as the London Mine, and is located at or near Section 18, Township 9 South, Range 78 West, 6th Prime Meridian. The proposed operation is to remove existing contaminated mine material to improve water quality in South Mosquito Creek and to reduce erosion of metal-bearing materials.

The proposed date of commencement is August 2023, and the proposed date of completion is August 2025. The proposed future use of the land is Industrial/Commercial.
