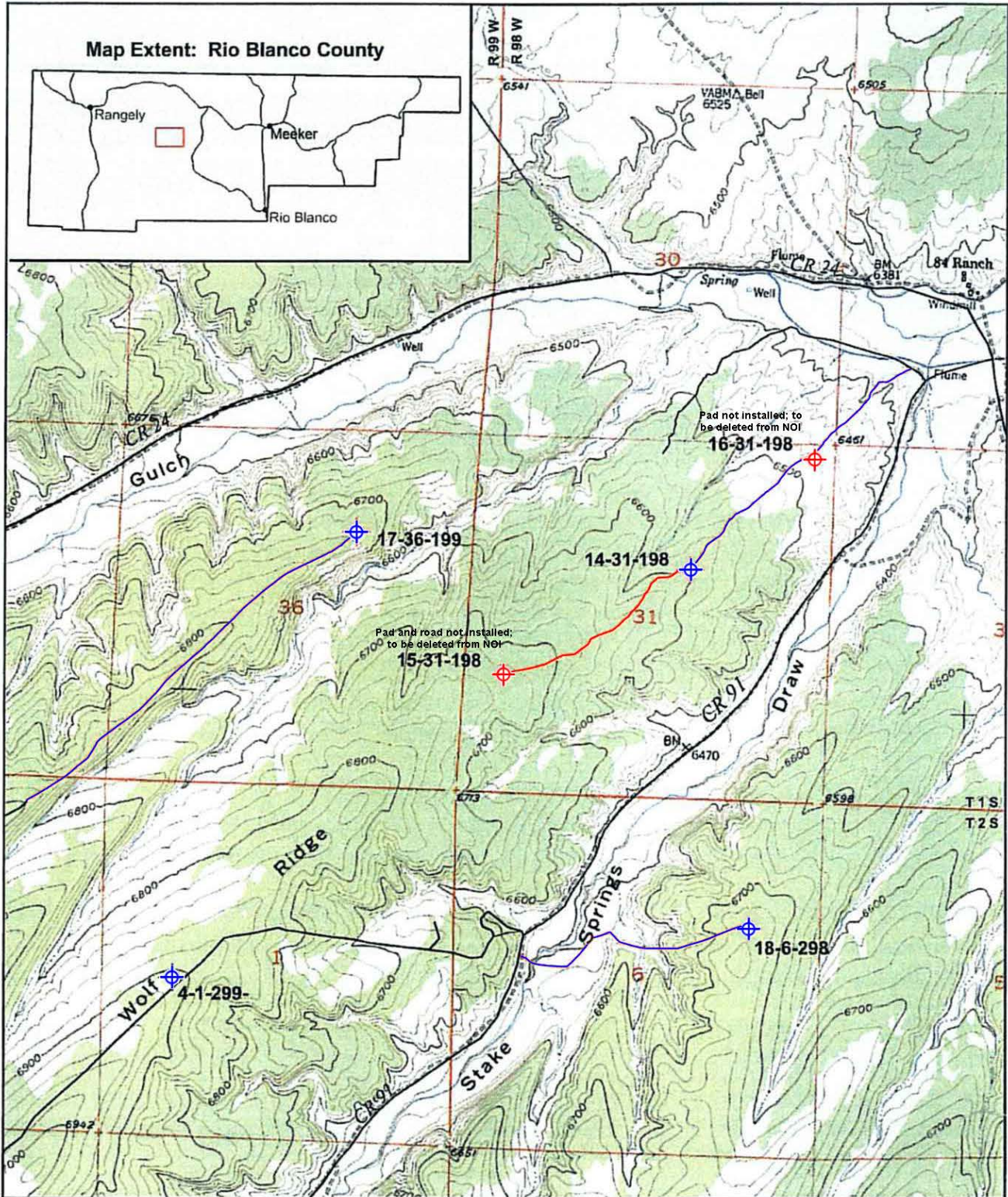
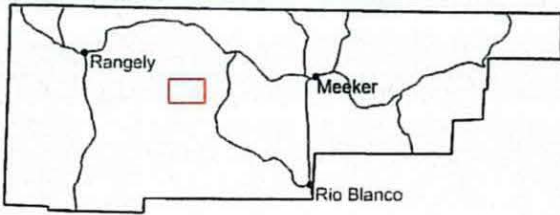


Map Extent: Rio Blanco County

USGS 7.5 Minute Quadrangle: Wolf Ridge

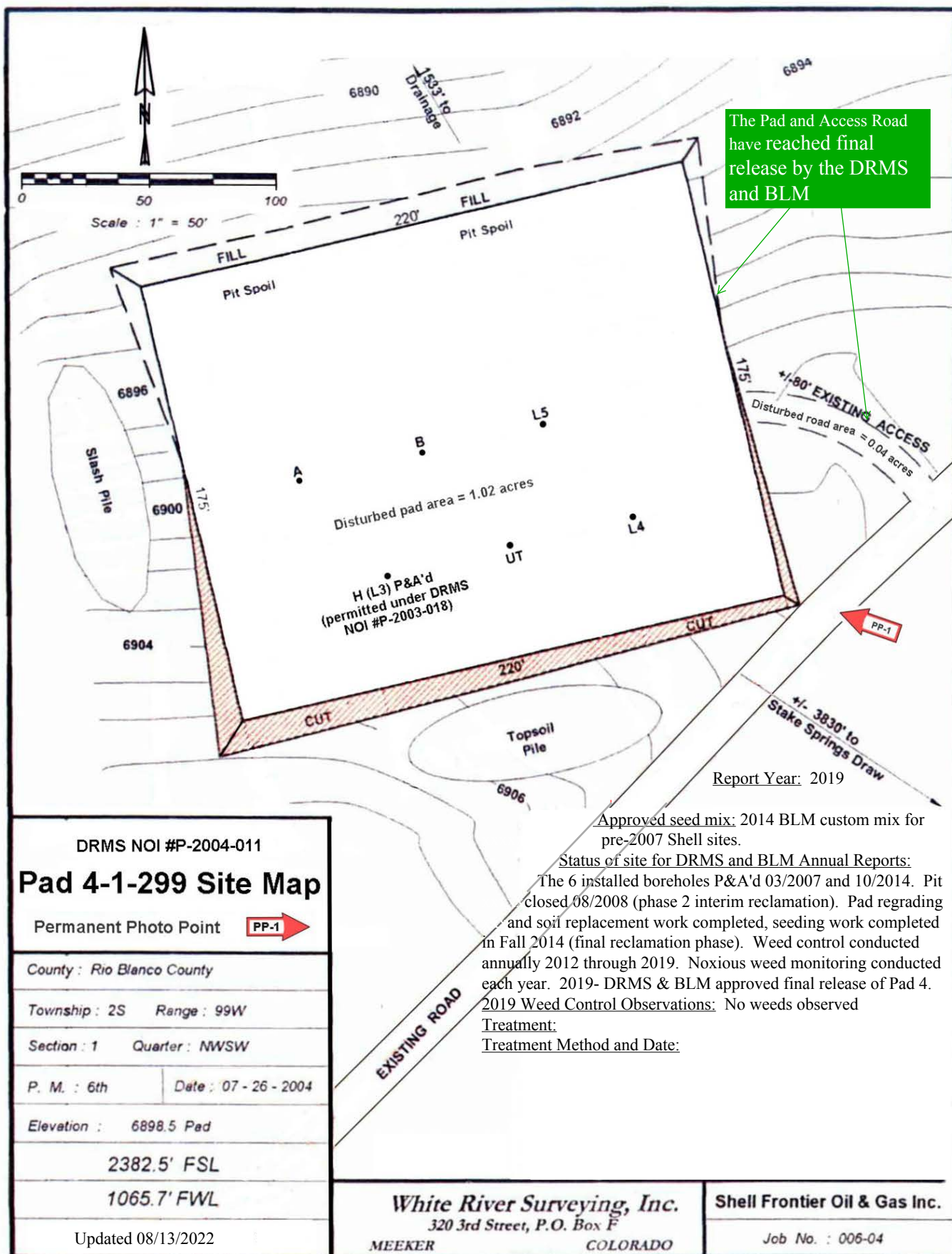

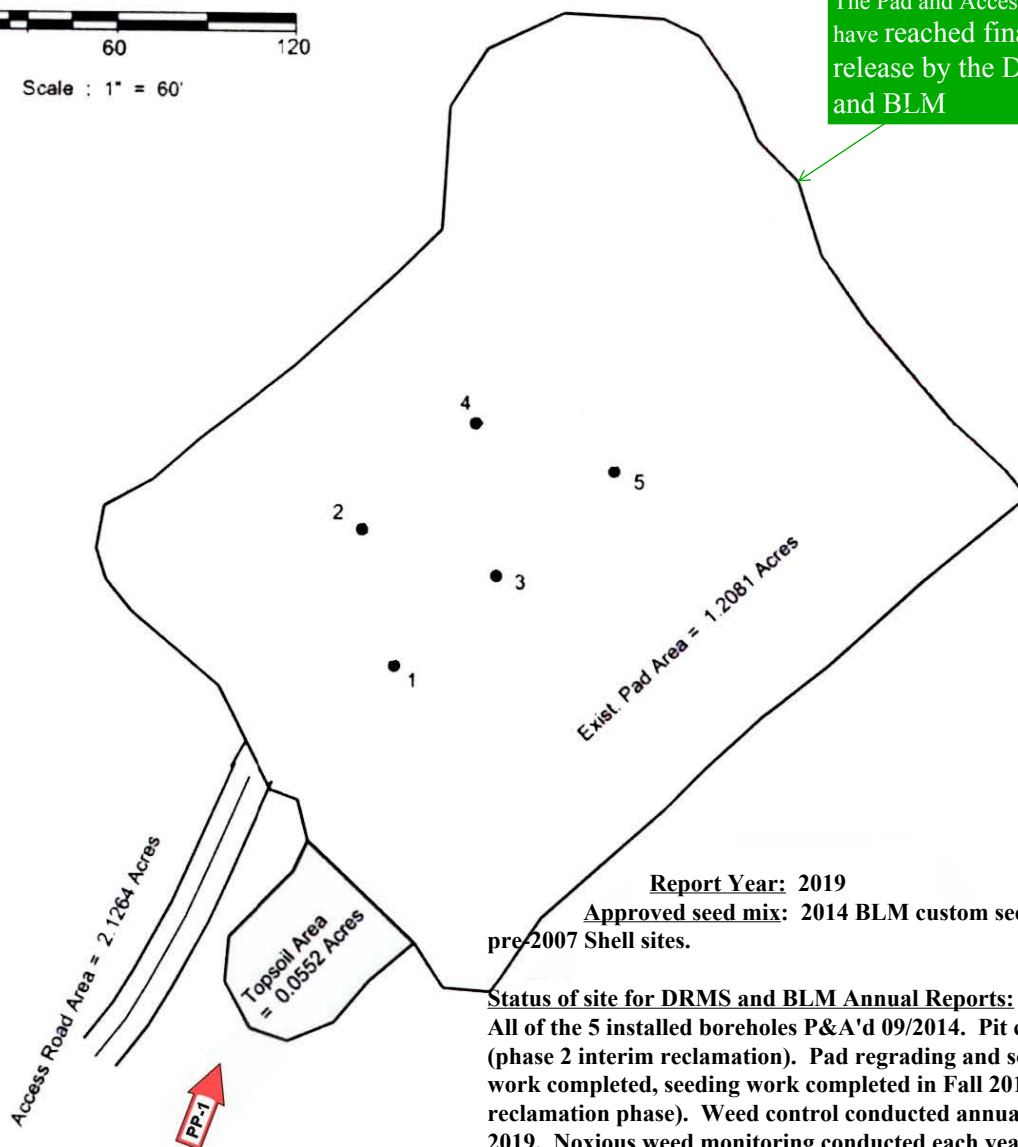

1 of the 6 installed boreholes P&A'd (11/2006). Pit closed, some seeding done for ground cover 10/2008 (phase 2 interim reclamation).

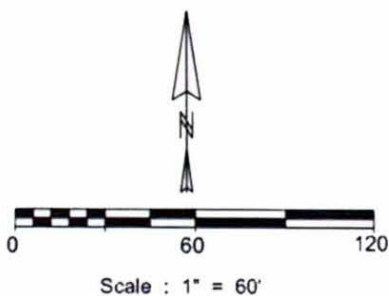
Remaining 5 boreholes P&A'd 09/2015. Pad regrading and soil replacement work completed, seeding work completed in Fall 2014 (final reclamation phase). Weed control conducted annually 2012 through 2022. Noxious weed monitoring conducted each year. 2019- DRMS and BLM approved final released of pad 18 per regulatory standards. The lower 0.83 acres of the access road remains under regulatory review.

2022 Weed Control Observations: Annual -Downy Brome

Treatment: Escort XP @ 1.5 oz/acre, Cornbelt LV6-2,4-D @ 24 oz./acre 1# A.I./acre), Vista @ 1.1 oz/acre, Round Up Pro Max @ 1.0 oz/acre 1# A.I./acre, Sun Wet @ 2 at/100 gal, Hi-lite Dye @ 24 oz./100 gal.. (A.I. = Active Ingredients.)
