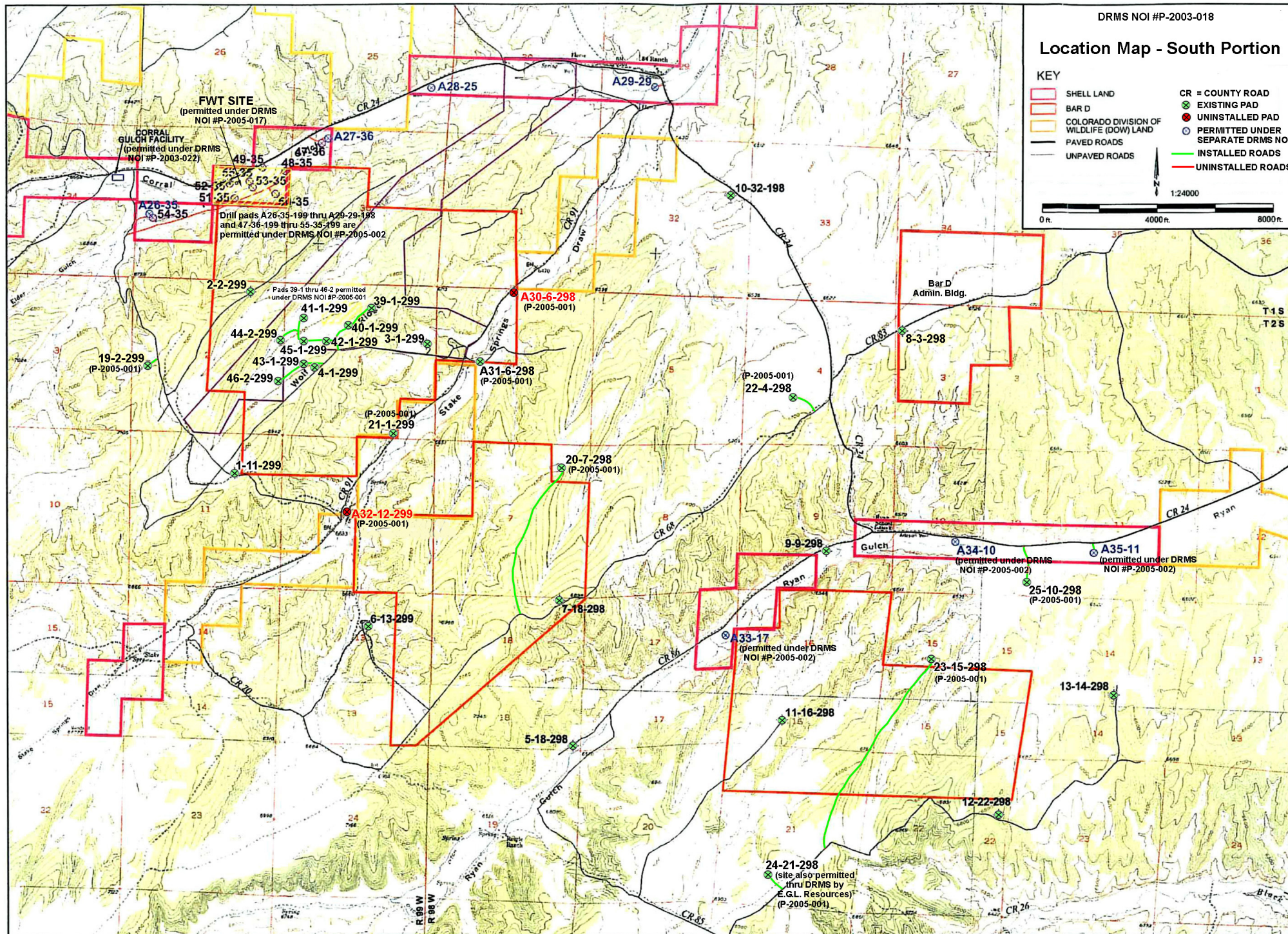
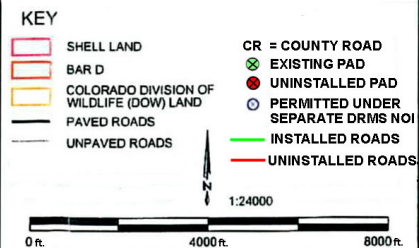


DRMS NOI #P-2003-018

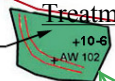
Status of site for DRMS and BLM Annual Reports: Part of Pad seeded 2004 (phase 2 interim reclamation). The two installed boreholes P&A'd 12/2007 and 11/2010. Final grading and seeding conducted in 2010 (final reclamation phase) Weed control conducted annually 2012 through 2022. Noxious weed monitoring conducted each year.

2022 Weed Control Observations: minimal weeds observed

Treatment: Escort XP @ 1.5 oz/ac, Cornbelt LV6-2,4-D @ 24 oz./acre, Vista @ 1.1 oz/acre, Round Up Pro Max @ 1.0 oz/acre 1# A.I./acre, Sun Wet @ 2 qt/100 gal., Hi-Lite Dye @ 24 oz./100 gal.. (A.I. = Active Ingredients.)

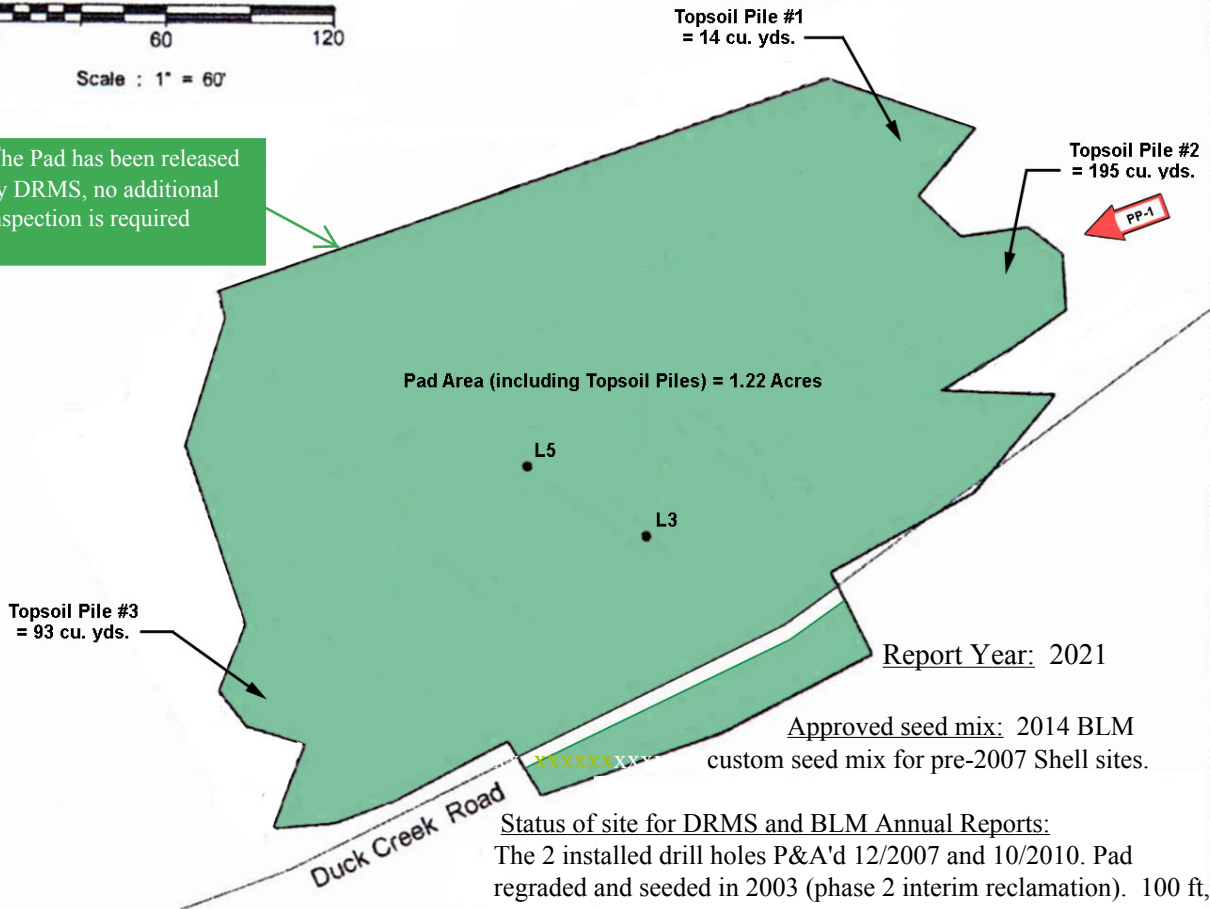
Pad 56-16-199 (B1-16) Access Map

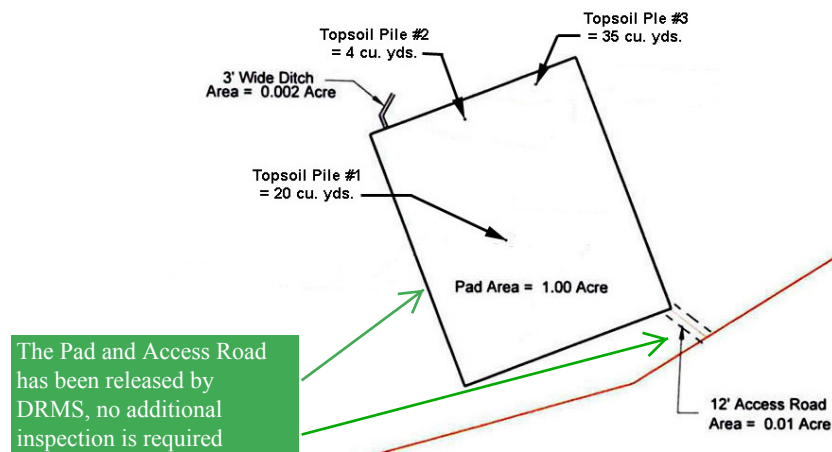

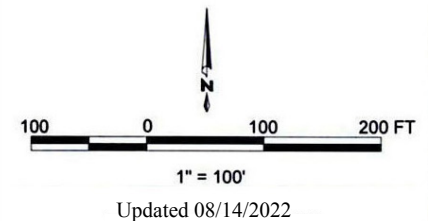

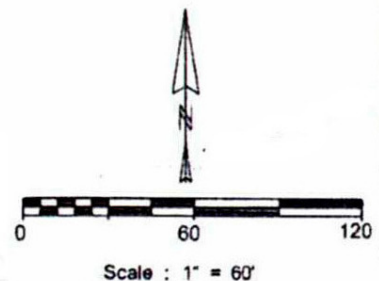
