Dear Mr. Lennberg,

In accordance with Rule 3, Section 3.1.7 (9) of the Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for Hard Rock, Metal, and Designated Mining Operations (Rules), the Cripple Creek and Victor Gold Mining Company (CC&V) hereby provides the Division of Reclamation, Mining, and Safety (Division) with a formal notification of water quality parameter exceedances.

CC&V collected third quarter groundwater compliance samples from monitoring well GVMW-8B and GVMW-22A on July 25, 2023.

Upon review of received analytical reports, CC&V determined monitoring wells GVMW-8B and GVMW-22A exceeded the Regulation 41 Table Value Standard for Fluoride.

Table 1 below lists these exceedances by the location and the associated parameter. The graphs contained in Attachment A demonstrate the parameter trend for the collected data.
