## Re: Chambers Pit (M-1980-136) TR-5, Third Adequacy Review

Dear Mr. Burkey,

This adequacy review follows the Division's inspection of August 14, 2023. Please see the comments below (older text is italicized).

- 1. [Mine Plan this item has been addressed]
- 2. [Affected area this item has been addressed]
- 3. The proposed text of Exhibit E states that backfilling and grading is complete at the site. Again, this seems to be inconsistent with the most recent Annual Report, which states that 35 acres have been backfilled and graded. Please clarify the status of backfilling and grading at the site.

Per the July 27<sup>th</sup> letter, backfilling and grading has been completed. In order to remove this task from the cost estimate the Division will need to verify the final topography. An inspection will be scheduled for this purpose during the week of August 15. Since the Reclamation Cost Estimate will need to be updated with TR-5, and the largest item in the current cost estimate (2010) is for backfilling and grading, the approval of TR-5 will be delayed until after the inspection has been completed.

The site was inspected on August 14, 2023. It was found that there are some areas of the site which have not been graded to a 3H:1V slope or shallower (the inspection report has complete details).

Please revise the text of Exhibit E, Item 1, specifically the sentence which reads: "All final mining slopes have been backfilled and graded to their final reclaimed 3H: 1 V slopes or shallower". The revised text should either retain the commitment to final slopes of 3:1 or shallower, or propose (with reasonable justification) specific areas where there will be a variance to the slope gradient commitment. Note that the postmining topography should be accurately depicted on the map in Exhibit F, since this will be the reference used during the bond release process.

- 6. [Landowner consultation this item has been addressed]
- 7. [Revegetation success criteria this item has been addressed]
- 8. Please correct the typo in Exhibit E, Item 1 which refers to the Hayden Gravel Pit.

The decision due date for TR-5 is August 25, 2023.
