Randy Foster:

On August 15, 2023, the Division of Reclamation, Mining and Safety (Division) filed your Technical Revision request (TR-3) for the Kagie Gravel Pit, Permit No. M-1979-102. During review of the material submitted, the Division determined that the following issue(s) of concern need to be adequately addressed before the Technical Revision can be considered for approval. Please provide the following:

1) The Annual Report Map submitted for 2023 (attached), shows that the total site acreage is 9.9 acres. This map looks to be done by a certified land surveyor. However, the Mining and Reclamation Plan maps submitted with this TR show a total permitted acreage of 9.6 acres. Please elaborate on the methodology used to determine the permitted acreage on maps submitted for these adequacy reviews. If measurements have not been completed by a certified land surveyor, the Division will assume that 9.9 acres is the total permitted area and revised Mining and Reclamation Plan maps will need to be submitted.

Please submit your response(s) to the above listed issue(s) by Friday, **September 8, 2023**, in order to allow the Division sufficient time for review. If you cannot address the above issues by September 8, 2023, please request an extension to the decision due date in order to ensure adequate time for the Division to review the materials. A decision due date of September 14, 2023 has been set. If any adequacy issues remain by the decision due date the Division may deny your request.

The Division will continue to review your Technical Revision and will contact you if additional information is needed.


