Dustin,

George's letter is not factual. To start with, George terminated our access to the Idaho on October 22, 2021. We had a two year notification requirement for this to take effect in our agreement with Wildcat from 2017 so we were trying to complete the removal of the Idaho from our permit prior to October 23, 2023. A copy of George's letter terminating our access agreement is attached.

I find the statement in the second paragraph that WMC obtained the permit in 2017 particularly offensive. Wildcat did not have the money to complete the reclamation required in the 2016-17 timeframe so we funded those efforts. The owner of the Mayday at that time was David Tippit who was disgusted with Wildcat and was not going to renew the lease with them so we stepped in and purchased the Mayday. We have funded all of the carrying costs of the mine since 2017 and have told Wildcat for over a year that we were going to remove the Idaho from our permit because of the cost of maintaining the CDPHE Permit on the Idaho. We offered to keep the permit as it currently is if Wildcat would fund the cost of the water permit required by CDPHE but this was never acknowledged or accepted by Wildcat. Their position is that we should fund the permit on the Idaho for their benefit. We obviously do not agree with this approach.

We have agreement from CDPHE that the Mayday does not contribute to the flow of the seep on the Idaho. This has been argued extensively but the fact is that it would require a water pressure of over 300 psi in the Mayday adit to lift water up to where it could flow into the Idaho. The flow of water from the seep on the Idaho is actually beneficial as a source of water in the area even though it requires extensive testing to meet CDPHE Permit Requirements. Such testing is the responsibility of the owners of the Idaho not the Mayday and of course this is not required once the Idaho is removed from our permit.

The lease the Idaho had on the Mayday with Tippit required that all equipment be removed in 90 days from the expiration of the lease that Wildcat had on the Mayday. We have told George continuously that he can reclaim a ball mill and two generators that were left on the Mayday despite the stipulation of 90 days in Wildcat's lease on the Mayday. I find it particularly curious that George continues to think Wildcat owns this equipment and that Sunrise Mining should be required to move the equipment back to the Idaho.

We look forward to maintaining a responsible operation on the Mayday and operating correctly so that we are in compliance with the regulations as they apply to our work. We are looking forward to meeting you Tuesday August 29 to inspect the Mayday.


