I apologize for the wildly belated reply to the Division's response of our filed complaints (Citizen Complaints CT3 and CT5). Our response to the Division's letter dated February 7, 2023 is below. Thank you in advance for your time and attention on this.

#### Citizen Complaint CT-3: Increase in Truck Traffic

**DRMS Response:** "Increase in truck traffic: The Division does not have jurisdiction over complaints regarding the increase in truck traffic at the site and those complaints are best addressed through Boulder County."

We respectfully disagree with the Division's position that DRMS lacks jurisdiction over the increase in truck traffic arising from operations at the CEMEX Lyons plant under the Lyons Quarry Permit.

In your response, DRMS relies upon a narrow interpretation of Construction Materials Rule 1.1(30) to conclude that its jurisdiction does not extend to the increase in truck traffic. Rule 1.1(30) defines a "mining operation" as including "transportation or processing on affected lands." We are arguing that the sharp increase in truck traffic following the closure of the Dowe Flats mine materially impacts the "transportation on affected lands," and therefore, squarely falls within DRMS's jurisdiction.

The term "transportation or processing on affected lands" should be interpreted broadly to encompass activities such as increased truck traffic that have significant implications for the mining operation, environment, and community. The increased truck traffic is integrally related to the CEMEX Lyons plant's operations — an operation that has undergone a substantial change in its activities related to transportation, as it has transitioned away from being a connected mining operation to a stand alone operation that many would consider a "custom mill". Given that the plant's operations are subject to DRMS's oversight, DRMS should require an Amendment or Technical Revision under its own rules governing permit alterations.

Further, the change in transportation materially impacts the environment and the community which, again, are subject areas under DRMS's purview. The increase in truck traffic could lead to:

 Road Degradation: CEMEX's increased trucking activity is approximately double their baseline usage. CEMEX needs upwards of 2500 tons of raw material per day to operate, which would take about 80 haul trucks (35-ton) per day to transport. Note: each 35-ton truck does the damage to roads of 160,000 1.5 ton passenger vehicles (ref: <a href="https://doi.org/10.1001/journal.o <u>law</u>.), which means that CEMEX is adding the impact of ~12.8 million passenger vehicles to our roads every day.

- A local resident filmed a time-lapse video on Friday, February 10, 2023, taken over a 90 minute period (10 shale trucks were recorded in 90 minutes. Note that Fridays tend to be slower days, so this is on the very low end of what local residents are seeing). Link: <a href="mailto:bit.ly/cemextrafficfeb10">bit.ly/cemextrafficfeb10</a>
- Increased Accident Risk: In addition to the below, we circulated a community petition
  earlier this year on a separate, but related, matter. If you review the comments in the
  included petition, you will find more than 100 comments that include concerns and
  frustrations around the nuisance and hazards created from CEMEX's operational
  changes.
  - According to the U.S. Department of Transportation, in 2019, large trucks were involved in 4,119 fatal crashes, 107,000 injury crashes, and 350,000 property-damage-only crashes.
  - Research also indicates that heavier trucks are more likely to be involved in accidents that result in fatalities or serious injuries. Given that each of the 80 additional trucks would be carrying 35 tons, the risk of severe accidents may increase.
  - An increase in heavy truck traffic can lead to congestion, which itself is a factor in many road accidents. More vehicles on the road can mean less maneuverability for all drivers, increasing the likelihood of an accident.

#### Elevated Noise and Air Pollution Levels:

- Elevated Noise: Heavy trucks typically generate noise levels between 85 and 91 decibels (dB). For perspective, noise levels above 70 dB can cause stress and annoyance, and prolonged exposure to noise above 85 dB can result in hearing damage. Also, the impact of noise pollution is cumulative. An increase of 80 trucks per day could significantly elevate noise levels in the affected areas.
- Elevated Air Pollution: Heavy-duty trucks are significant sources of nitrogen oxides (NOx), particulate matter (PM), and carbon dioxide (CO2). NOx and PM are associated with a range of health issues, including respiratory and cardiovascular diseases. Below are some estimations on the increased emissions; one of the key assumptions is that this is based on a 40-mile round trip average, which was intentionally generous. CEMEX is sourcing its shale from the Arcosa Lightweight facility in Golden (48 miles roundtrip), and is sourcing its limestone from their Weaver Quarry in Wyoming (100 miles roundtrip).
  - Nitrogen Oxides (NOx): On average, a heavy-duty diesel truck emits approximately 0.4 kg of NOx per mile traveled. If the average round trip is 40 miles and there are 80 additional trucks, the added NOx emissions could be: 0.4 kg/mile x 40 miles / trip x 80 trucks = 1280 kg or 1.28 metric tons of NOx per day.
    - 1.28 metric tons per day translates to approximately 467.2 metric tons annually. A passenger vehicle emits about 0.00002 metric tons of NOx per year. Therefore, the annual NOx emissions from

this increased trucking activity would be equivalent to the emissions from about 23,360,000 cars.

- Particulate Matter (PM): Diesel trucks emit approximately 0.02 kg PM per mile. Using the same assumptions: 0.02 kg / mile x 40 miles / trip x 80 trucks = 64 kg or 0.064 metric tons of PM per day.
  - 0.064 metric tons per day means about 23.36 metric tons annually. One wood stove emits about 0.00004 metric tons of PM per year. The annual PM emissions would be like having around 584,000 wood stoves operating for a year.
- Carbon Dioxide (CO2): A heavy-duty truck emits about 2.2 kg of CO2 per mile on average. Again, using the same assumptions: 2.2 kg / mile x 40 miles / trip x 80 trucks = 7040 kg or 7.04 metric tons of CO2 per day.
  - 7.04 metric tons per day equates to 2,569.6 metric tons annually.
    The average U.S. household emits about 20 metric tons of CO2
    each year. This amount of CO2 emissions is akin to what 128,480
    households would emit in a year.

These are all legitimate public safety and environmental concerns that DRMS should consider within the scope of its regulatory functions. The regulations governing DRMS anticipate that mining operations may evolve and affect the public and environment differently over time. In light of these anticipated changes, the public has a vested interest in participating in a review of these new conditions, facilitated by DRMS.

In summary, we respectfully submit that DRMS's jurisdiction does indeed extend to the increased truck traffic resulting from the CEMEX Lyons plant's changed operations - the sharp increase in truck traffic following the closure of the Dowe Flats mine materially impacts the "transportation on affected lands," and therefore, squarely falls within DRMS's jurisdiction. We, therefore, request that DRMS reevaluate its stance and take appropriate action, including initiating a review for a permit revision or amendment.

#### Citizen Complaint CT-3: Custom Mill

**DRMS Response:** "Custom Mill: The term milling is used to describe extractive metallurgical processing as presented in the Hard Rock, Metal, and Designated Mining Operations Rules. The Lyons Quarry is a Construction Materials operation and therefore not subject to the Hard Rock Rules."

We respectfully disagree with the Division's position that the change in the sourcing of raw materials for CEMEX's Lyons Quarry plant—from an adjacent mine to trucking in 100% of raw materials from distant locations—does not constitute a significant alteration of the operation that should necessitate an amendment to the existing permit. Here are several key points to consider:

- Regulatory Scope and Definitions: "Mining Operation" vs. "Custom Mill": While DRMS may define "milling" in the context of extractive metallurgical processing under the Hard Rock Rules, the actual situation here indicates a shift in the nature of the operation. According to DRMS regulations, a "Mining Operation" often includes the associated transportation or processing of material on the affected lands. By losing its adjacent source mine and relying solely on trucking in raw materials, the plant has shifted its operational character, effectively becoming more like a "Custom Mill."
- Interconnected Operations: If CEMEX's Lyons plant and the adjacent Dowe Flats mine were considered interconnected operations under the same permit, the closure of the mine changes the entire scope of the operation, which should trigger a review and potential permit amendment.
- Scope of Oversight: A DRMS employee noted that stand-alone cement plants might
  not fall under DRMS jurisdiction. This itself highlights that a change has occurred that is
  so significant it potentially changes which agency has jurisdictional oversight. If that's not
  a compelling argument for an operational review and a potential permit amendment, it's
  hard to say what is.
- Transportation Risks: The increase in trucking in raw materials significantly impacts
  traffic and could also lead to environmental and safety concerns, such as increased risks
  of spills or accidents. While DRMS may not typically oversee traffic, the drastic change in
  the source of raw materials and the method of their delivery could reasonably be
  considered under their purview as it affects the overall mining operation.

For these reasons, the significant operational changes warrant a new permit evaluation process, including public comment and an assessment of the new operational and environmental impacts. DRMS should consider these changes substantial enough to require a permit amendment, given that the changes even raise questions about whether the operation should continue to be under DRMS's jurisdiction at all.

#### Citizen Complaint CT-3: Current Activities at the Lyons Quarry

**DRMS Response:** Current Activities at the Lyons Quarry: Pursuant to Construction Materials Rule 1.1(30) a Mining Operation includes transportation or processing on affected lands. Currently approved site operations are included in that definition, and the Division finds that a revision to the Lyons Quarry permit is not necessary or required.

In response to the Division's assertion that a permit revision or amendment for the Lyons Quarry is neither "necessary nor required" under Construction Materials Rule 1.1(30), despite the significant changes in operations that have taken place due to the closure of the Dowe Flats mine:

First, Rule 1.1(30) defines a "Mining Operation" as including "transportation or processing on affected lands." In the spirit of this definition, it is crucial to adopt an expansive interpretation that incorporates not just literal on-site activities but also the ancillary impacts that significantly affect both the lands in question and the surrounding community.

Since the closure of the Dowe Flats mine, the Lyons Quarry has essentially transformed from what was once a connected "Mining Operation" to what now essentially functions as a standalone "Custom Mill," relying on trucking raw materials from distant locations. This shift has caused a substantial increase in truck traffic, leading to public nuisance, safety risks, and substantial environmental impact that cannot be ignored. Such a marked change in operational logistics has indirect but significant impacts on the "affected lands," which should fall squarely under DRMS's jurisdiction.

It is important to remember that the very raison d'être of your agency is to regulate the "affected lands" in a manner that preserves the integrity of both the environment and the community it serves. The narrow interpretation of Rule 1.1(30) not only undermines this mission but also provides a loophole for Lyons Quarry to avoid the scrutiny that these significant changes warrant.

In light of these substantive operational shifts and the accompanying broader implications, I respectfully submit that the Division of Reclamation, Mining and Safety should require a permit amendment or at least a technical revision for the Lyons Quarry. Such a review would allow the agency to properly address the altered circumstances and potentially mitigate the adverse effects on both the environment and the community. This will ensure that the permit conditions are tailored to the operation's current state, aligning more closely with the true intent of the regulations you administer.

#### Citizen Complaint CT-5: Reclamation Plan

**DRMS Response:** Reclamation Plan: In September of 2003, the Division approved Technical Revision No. 2 (TR2) allowing on-site disposal of concrete rubble for use at the close and demolition of the concrete plant. The Division finds that a revision to the Lyons Quarry permit is not necessary or required at this time for this activity.

In response to the Division's determination that the modifications to the Reclamation Plan for Lyons Quarry, specifically the allowance for on-site disposal of concrete rubble, do not necessitate a permit revision or amendment, we respectfully disagree with this assessment and urge you to reconsider in light of the substantial environmental and public health risks involved, as well as the agency's mission and purpose.

The Division of Reclamation, Mining and Safety exists to protect the public, miners, and the environment during mining and reclamation. The current Reclamation Plan, approved via

Technical Revision No. 2 (TR2) in 2003, allows for the on-site burial of a significant amount of concrete rubble—up to 80,000 cubic yards. Such a massive volume of buried material poses an undeniable risk to both the environment and public health, particularly given the geophysical realities of the site. In Boulder County, activities that require a Special Use permit also mandate an Environmental Impact Study to assess the potential consequences on public health, environmental safety, and community welfare. Even though the Lyons Quarry operates under a mining permit rather than a Special Use permit, the magnitude and the potentially far-reaching impacts of its activities are on par with the types of projects that would require such a permit—and hence an EIS—in Boulder County. We believe that the lack of an EIS for this noteworthy change to the reclamation plan needs to be corrected, and a public process should follow.

It's worth noting that large portions of the Lyons Quarry are located in a floodplain, and the water table is as shallow as 7 feet. This makes the potential for water contamination incredibly high. Moreover, the majority of nearby residents rely on well water; thus, any impact on the water flow would have immediate and direct effects on their daily lives. Some additional environmental concerns include:

- Leaching: Concrete can contain a variety of materials that may leach into the soil over time, possibly contaminating ground and surface water. This could include lime, which raises pH levels, and other additives or coatings that may be hazardous.
- Soil Quality: Large amounts of buried concrete can adversely affect soil quality, inhibiting plant growth and disrupting local ecosystems.
- Water Flow: The presence of buried concrete can disrupt natural water flow systems, potentially leading to erosion, altered sediment delivery, and flooding issues downstream.
- Water Contamination: If the concrete rubble contains hazardous substances that leach into groundwater, this could contaminate local water supplies, posing a health risk to nearby communities.
- Air Quality: The process of burying such a large amount of concrete could generate dust and particulate matter, affecting air quality and potentially posing respiratory hazards.

The changes made to the reclamation plan in Technical Revision No. 2 are not inconsequential changes; they are substantial and potentially hazardous alterations that should trigger an in-depth review process involving public notification and comment.

By including these potentially hazardous alterations in a Technical Revision, as opposed to an Amendment, CEMEX and DRMS effectively sidestepped the public notice process. The absence of public scrutiny not only undermines DRMS's mission, but also disregards the substantive changes made to the Reclamation Plan that have far-reaching implications. The scale and potential consequences of this activity necessitate a more rigorous review process commensurate with an Amendment, rather than a less-stringent Technical Revision.

In conclusion, I urge the Division to reclassify the 2003 changes to the Reclamation Plan for Lyons Quarry as requiring a formal Amendment to the permit. Such a designation would not only align with the agency's mission to protect public and environmental health but also provide a necessary avenue for public input, thereby ensuring a more responsible and accountable operation.

Board of Boulder County Commissioners,

659 people have signed a petition on Action Network telling you to Sign to Stop Boulder County's #1 Polluter!.

Here is the petition they signed:

Dear Commissioners Levy, Loachamin, and Stolzmann,

We are writing to formally request that you take action and uphold the Boulder County Land Use Code regarding the termination of Nonconforming Use (article 4-1003) as it relates to the CEMEX Lyons property, located at 5134 Ute Highway.

After the closure of its Dowe Flats mine, in October 2022, CEMEX Lyons began trucking in all of their raw materials from remote locations. County residents have observed and complained publicly on Facebook and other forums about 10-20 'new' 35-ton trucks driving to CEMEX Lyons via Highways 36 and 66 every hour. This includes significant traffic through the City of Boulder from a shale operation south of Boulder County.

This is a significant alteration and enlargement from the baseline use, as the truck traffic has roughly doubled. These changes are so substantial that they have caused CDOT to require a new access permit.

CEMEX's recent operational changes have resulted in:

- Significantly more intensive use of their land and/or its services,
- Hazards and public nuisance on/off the property,
- Increased threats to public health and safety, and
- An adverse impact on the character of the neighborhood.

CEMEX has also created new shale stockpiles, and the size and land area occupied by the stockpiles of other materials has increased dramatically. These new and increased stockpiles are now highly visible from US-36, Hygiene Road, and by numerous neighbors. This is an enlargement and alteration of use, affects the character of the neighborhood, and is a visual nuisance off the property.

These new, intensive uses clearly trigger the non-conforming use termination clause (Article 4-1003.C.1.d) for CEMEX's Lyons-based plant on a number of fronts, which now compels the Boulder County Director of Land Use to send a notice of termination (Article 4-1003.H.1) determining that the property owner's right to continue a non-conforming use has, or may have, been terminated because of violations of Section 4-1003 (alterations of use) of the Land Use Code. Upon receiving the letter, the property owner has 30 days to provide evidence to the Director of Land Use to the contrary, appeal to the Boulder County Commissioners, or apply for a Special Use Permit.

Termination of the non-conforming use and denial of a Special Use Permit would ultimately result in the closure and demolition of the plant as the cessation of operations would trigger CEMEX's DRMS (Colorado Department of Reclamation, Mining, and Safety) Reclamation Plan.

What we are asking of you, our Boulder County Commissioners: Require that Boulder County

Land Use Director, Dale Case, act on Article 4-1003.H.1 (notice of termination) by sending a letter to CEMEX Lyons indicating that nonconforming use has or may have terminated in accordance with Section 4-1003 of the Boulder County Land Use Code (alteration of use). For your convenience, we have included a draft letter that Director Case may use for reference. As a reminder, per Land Use Article 4-1001.A, the County has a duty to eliminate nonconformity "as speedily as justice will permit".

It is also worth noting that Article 4-1003.H.2 states, "...any failure by the Director to provide a notification of a determination of termination as provided for in this Section shall in no way entitle the property owner to continue or resume a nonconforming use terminated by operation of this Section 4-1003(H)." This means that any past failures to enforce the above codes do not give the property owner the right to continue those alterations of use. We have also attached a matrix of 15 past alterations that may have met the criteria in Article 4-1003 (alteration of use) and could have triggered Section 4-1003.H.1 (notice of termination).

We are simply asking that you enforce policies that were thoughtfully put into our Land Use Code to protect the community at large. Taking this step may very likely be one of the most impactful things you will have the opportunity to do in your lifetime to fight climate change. CEMEX Lyons is the #1 C02 emitter in Boulder Count (representing > 7% of all emissions), with annual greenhouse gas emissions equal to the annual emissions of ~30,000 people, and they have every intention of hanging around 'indefinitely' if we let them.
