Kirtright Pit Activity Continues without DRMS or LarCo Engineering Planning and Approvals

This short slide deck shows the extensive land movement in the Kirtright Pit from August 28, 2023 to September 13, 2023 without a current reclamation plan or flood plain approval. The last approved reclamation plan was in 2015, and looks nothing like what has been happening in recent years.

Early September DRMS received first notice of this behavior, and there have been 2.5 weeks of continued excessive digging by Kirtright and his contractor. Without any consequences to abuse of rules and regulations, the behavior continues. Larimer County Engineering has been notified for flood planning purposes.



This shows the location of the dig in the SW corner of the Kirtright property . What was a series of canals has now become an island with water surrounding it.

Across the driveway to the south is the Thompson-River Ranch neighborhood, just feet from this ditch.
