

# EXHIBIT M – OTHER PERMITS AND LICENSES

Meeker Sand & Gravel: M-1976-038

The entire gravel pit area (existing and proposed expansion) were granted Special Use Permits by Rio Blanco County for gravel mining operations under Bob Dearman's ownership 1975. Board of County Commissioner (BOCC) minutes indicating this are included as Exhibit M-1. The post-mining uses (Industrial and Dry Rangeland) have also been approved.

A driveway permit with Rio Blanco county was secured previously and is on file with the owner/operator.

Current mine has a Stormwater Discharge Permit with the State of Colorado: #COG-501769. This permit will be ammended to include the proposed expansion area prior to affecting the land in the new area, although no discharge is expected nor will be allowed.

Current mine has APEN's for the stationary concrete batch plant (#13RB2399.XA) and for the mining operation (93RB261F / AIRS ID: 103-0060-002). No new APEN's will be required as the batch plant will remain on-site in current location and mining operation will simply be moving westward, with the same annual tonnages and production levels anticipated.

No radioactive source material license will be necessary.

No State Historical Preservation Office clearance will be necessary.

No disposal of dredge and fill material (404) permit will be necessary. No permits to construct a dam will be necessary.

No well permits, explosive permits or highway access permits will be necessary.

No US Forest Service or BLM permits will be necessary.

No other permits or licenses will be necessary.

THE BOARD OF COUNTY COMMISSIONERS MET IN REGULAR SESSION ON JUNE 2, 1975.

PRESENT WERE COMMISSIONERS HARRY PEACOCK, BILL BRENNAN AND BILL BROWN, CLERK TO THE BOARD SUE MANTLE, COUNTY ATTORNEY GEORGE BENNER, AND BUDGET DIRECTOR FRANCIS KENNEDY.

IN THE ABSENCE OF DUANE RENBORG WHO WAS ATTENDING A MEETING IN DENVER, DON ROACH, COUNTY ZONING OFFICER GAVE THE PLANNING DEPARTMENT REPORTS.

CHAIRMAN PEACOCK READ THE HEARING NOTICE FOR THE CONDITIONAL USE PERMIT FOR THE DEARMAN GRAVEL PIT. MR. ROACH INFORMED THE BOARD THAT THIS HAD BEEN RECOMMENDED BY THE PLANNING COMMISSION. HEARING NO OBJECTIONS A MOTION WAS MADE BY BILL BRENNAN THAT THE PERMIT BE APPROVED FOR EIGHTY ACRES AS CALLED FOR IN THE APPLICATION. SECONDED BY COMMISSIONER BROWN. CHAIRMAN PEACOCK CALLED FOR A ROLL-CALL VOTE AS FOLLOWS:

A COPY OF THE APPLICATION IS ATTACHED TO THE MINUTES OF THIS MEETING.

MR. GEORGE WIDDINS OF THE U. S. FOREST SERVICE MET WITH THE BOARD AND PRESENTED THE ANNUAL OPERATING PLAN FOR FIRE FIGHTING AND PROTECTION A CO-OPERATIVE AGREEMENT WITH THE COUNTY, BLH AND FOREST SERVICE. THE AGREEMENT WAS APPROVED AND SIGNED BY THE BOARD, AND UPON COMPLETION OF SIGNATURES OF THE BLH AND FOREST SERVICE A COPY WILL BE ATTACHED TO THE MINUTES.

THE BOARD APPROVED AND UPDATED THE FOREST SERVICE-COUNTY SHERIFF AGREEMENT FOR LAW ENFORCEMENT.

CHAIRMAN PEACOCK CALLED FOR BIDS FOR THE 1969 FORD V8 SEDAN OWNED BY THE COUNTY SHERIFF'S DEPARTMENT AS ADVERTISED. ONE BID WAS RECEIVED AS FOLLOWS:

THE BOARD APPROVED THE 3.2% BEER LICENSE TRANSFER FOR MICHEAL BRENNAN, D/B/A RIO BLANCO STORE.

MR. RUSS McDANIELS MET WITH THE BOARD TO REPORT ON THE SURVEY OF THE COLORADO HEALTH DEPARTMENT DEFICIENCIES IN THE PIONEERS HOSPITAL AND WALBRIDGE KING NURSING HOME. HE REPORTED THAT LAST YEAR'S REPORT WAS CARRIED OUT, AND THAT HE AND THE BOARD FELT ALL WAS IN ORDER TO COMPLY WITH THE STANDARDS FOR LICENSE AND APPROVAL, AND NOW IT SEEMED THAT TO COMPLY IT WILL COST SOME \$30,000.00.
